1	SRHR workshops with girls and women	Banaras, Uttar Pradesh Ranchi, Jharkhand	September October November 2017	Assessment of health issues and access to healthcare for girls and women from dalit communities in select areas of Benares, UP and girls and women from Ranchi, Jharkhand was carried out through meetings with girls and women local health care providers, organisations. Workshops with girls and women were conducted to build their awareness about menstruation, maternal health, uterine prolapse, etc., and relevant health programmes and schemes in their areas such as Janani Suraksha Yojana, Mamta Diwas, etc.	
2	Research Project- "Assessing the Status of Health System Delivery and Factors Determining Access to Quality Healthcare for Tribal Communities" by Sama in collaboration with the National Human Rights Commission (NHRC)	Select areas of Jharkhand, Chhattisgarh and Odisha	April 2017 – March 2018	Field work for the research was carried out during this period. The main objectives of the research were to understand the current status of public health care delivery system in the selected study areas, public healthcare utilization among tribal communities in the study areas and barriers faced in access to health care. An interim report regarding the progress of activities under the project was submitted to NHRC in December 2017.

This meeting aimed at establishing a dialogue on the use of genome editing technologies between European and Indian experts.
4	Workshops with adolescent girls in Delhi	Delhi- Tughlakabad, Haiderpur, Lajpat Nagar, Kamla Nagar	2017- 2018	Six workshops were conducted during this year to build awareness of adolescent girls about their reproductive health issues, on gender, etc.
5	Discussion on draft 'National Pharmaceutical Policy 2017' by Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers	Department of Pharmaceutic als, Ministry of Chemicals and Fertilizers, New Delhi	2017	Sama representative participated and provided feedback on the draft from a public health perspective and highlighted issues of lack of access to essential and lifesaving medicines, for e.g. the Anti Diphtheria Serum and Hydroxyurea in states such as Odisha, Chhattisgarh, etc.
6	Visits to Disha clinics (Adolescent Friendly Health Clinics) in North East Delhi	Delhi	2017-2018	Visits were made to Sanjay Gandhi Memorial hospital, Bhagwan Mahavir hospital, Dr. Baba Saheb Ambedkar hospital, PUHC Sonia Vihar and other places in North East Delhi where the DISHA clinics are located towards updating the current status, functionality and their outreach in the community and for adolescents.

The workshop included role plays, interactive exercises that the trainers could adapt in their trainings with adolescents.
8	State Level Dissemination Meeting on findings of Sama study on 'Exploring Mental Health Issues among Young Women'	Lucknow, Uttar Pradesh Jaipur, Rajasthan	28 July 2017 1 August 2017	The dissemination meetings organised by Sama were attended by organisations working with young women on various issues related to their health, education and participants from organizations, who were working in the areas where the research was conducted. Government representative, i.e. State Nodal Officer Mental Health, UP and the Rashtriya Kishore Swasthya Karyakaram (RKSK) Consultant in Rajasthan also attended.
9	National Dissemination Meeting on 'Exploring Mental Health Issues among Young Women'	New Delhi	11 August 2017	The dissemination meeting organised by Sama to discuss mental health issues based on Sama's study as well as the work by other organisations through panel discussions. About 45 persons from 34 organisations, networks, groups and individuals working directly with communities, engaged with research and advocacy on a range of issues including with young people, participated in the meeting. A representative from the Ministry of Health and Family Welfare (MoHFW) in charge of the Rashtriya Kishor Swasthya Karyakram (RKSK) also attended.
10	Short Course on Challenges to Access to Medicines	Delhi	16- 18 August 2017	The Course organised by Sama focused on various issues that affect or are related access to medicines such as universal healthcare, access to medicines in the human rights framework, ground realities relating to accessing life- saving medicines, drug pricing, experiences of free medicines schemes in Rajasthan and Odisha, ethical issues in research and access to medicines.

The team interacted with hospital administrators, doctors and other staffs in the health facilities. Meetings were also conducted with relevant government officials/departments to get insights into the implementation of the protocols.
